Other valid Government ID), and category/caste certificates (if applicable), along with two complete sets of self-attested photocopies.

2. **Service Bond:** The legal Service Bond must be duly filled, executed on non-judicial stamp paper, and signed strictly as per the format prescribed by the institute for the respective designation.
